## Correlation of Level 8 Topic Guide with Academic Content Standards\*

Most of the topics covered in level 8 have been introduced in previous grades. They are reintroduced within the first quarter (Lessons 1 - 36) and are systematically revisited and expanded upon throughout the edition. As a result of using *Simple Solutions Level 8 English Grammar & Writing Mechanics*, the students will be able to do the following:

Use **Context Clues** to find the meaning of unknown words.

Apply knowledge of **Connotation** and **Denotation** to determine meaning.

Infer meaning through understanding **Analogies**, **Synonyms**, and **Antonyms**.

Infer **Literal** and **Figurative** Meanings of words and phrases, including **Similes**, **Metaphors**, and **Idioms**.

Use **Greek**, **Latin**, and **Anglo-Saxon Roots** and **Affixes** to understand vocabulary.

Use **Resources & Reference Materials** (dictionary, thesaurus, glossary) to select more effective vocabulary and to determine meanings and pronunciations of unknown words.

Analyze **Cause** and **Effect** statements and differentiate between the two.

Distinguish and analyze **Fact** and **Opinion** statements.

Identify all **Parts of a Sentence**: simple and complete subjects and predicates, objects, modifying words and phrases, clauses, etc. Construct sentences using all parts correctly.

Identify and correctly use all **Eight Parts of Speech**.

Identify and use **Gerund**, **Infinitive**, and **Participial Phrases** correctly.

Use **Verbs** appropriately (perfect tense, transitive and intransitive verbs, linking verbs).

**Conjugate Regular and Irregular Verbs in All Tenses.**

Use **Subject-Verb Agreement** (with collective nouns, indefinite pronouns, compound subjects, and prepositional phrases).

Identify and appropriately use all types of **Pronouns: Nominative, Objective, and Possessive; Indefinite, Relative, Interrogative, and Demonstrative; Intensive and Reflexive.**

## Level 8 topics (continued)

Identify and employ Steps of **The Writing Process**.

Use **Organizational Strategies** to plan writing.

**Vary Sentence Structure** (simple, compound, complex and compound-complex).

**Proofread** and **Edit** writing using editing marks.

Identify and correct **Fragments** and **Run-ons**.

Use correct **Spelling** conventions.

Correctly apply **Punctuation** and **Capitalization** to written work.

Identify and correctly use **Clauses** (main and subordinate) and **Phrases**.

Use **Parallel Structure** to present items in a series and items juxtaposed for emphasis.

Use proper **Placement of Modifiers**.
